SUBJECT: **Adopt Resolution 2022-01: FY20-21 YE Final Budget Adjustments**

ISSUE:

Adoption of Resolution 2022-01 amending the Fiscal Year 2020-21 Budget for final year-end adjustments.

ANALYSIS/INFORMATION:

The Village Community Development District No. 7 Board of Supervisors adopted the Fiscal Year 2020-21 Budget at a public meeting held on September 10, 2020.

As is customary at the end of each fiscal year, the financial records are reviewed for any budget adjustments. Per State Statute 189.016, the governing body of each special district at any time within a fiscal year or up to 60 days following the end of the fiscal year may amend a budget for that year. This resolution will ensure that the actual expenditures are within budget appropriations and reduces the number of variances during the audit process.

Attached is Resolution 2022-01 to amend the Fiscal Year 2020-21 2015 Debt Service Fund for the additional prepayment revenues and expenses.


