OF THE BOARD OF COUNTY ORDINANCE  $\mathbf{A}\mathbf{N}$ SUMTER COUNTY, FLORIDA COMMISSIONERS OF THE VILLAGE COMMUNITY DEVELOPMENT CREATING DISTRICT NO. 2, PURSUANT TO FLORIDA STATUTES 190.005, ENCOMPASSING PORTIONS OF LANDS IN SECTIONS 1, 2, 3, 11 AND 12 OF TOWNSHIP SOUTH, RANGE 23 EAST, SUMTER COUNTY, FLORIDA; PROVIDING FOR THE MEMBERS OF THE BOARD OF PROVIDING FOR SUPERVISORS FOR THE DISTRICT; COMMUNITY DEVELOPMENT THE THE NAME OF PROVIDING FOR POWERS OF THEM DISTRICT: PROVIDING FOR REPEAL OF ORDINANCES DISTRICT; CONFLICT HEREWITH; PROVIDING SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Florida Legislature has passed the Uniform Community Development District Act of 1980 (otherwise known as Chapter 190, Florida Statutes) to provide an alternative method to finance and manage basic services for community development; and

WHEREAS, The Villages of Lake-Sumter, Inc., a Florida corporation, has petitioned the Board of County Commissioners of Sumter County, Florida, to grant the establishment of the Village Community Development District No. 2; and

WHEREAS, a public hearing has been conducted by the County Commission pursuant to the requirements and procedures of Chapter 190, Florida Statutes; and

WHEREAS, the Board of County Commissioners has considered the record of the public hearing and has decided that the establishment of the Village Community Development District No. 2 is the best alternative means to provide certain basic services to the community; and

WHEREAS, the Board of County Commissioners finds that the establishment of the Village Community Development District No. 2 is the best interests of all of the citizens of Sumter County, Florida;

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Sumter County, Florida, as follows:

Section 1. That the foregoing Preamble is hereby ratified and confirmed as true and correct by the Board of County Commissioners of Sumter County, Florida.

Section 2. That the petition to establish the Village Community Development District No. 2 is hereby granted.

Section 3. That the external boundaries of the District and the real property within the external boundaries of the District which is to be excluded is described on Exhibit A attached.

Section 4. That the initial members of the Board of Supervisors shall be as follows:

Section 5. That the name of the District shall be the "Village Community Development District No. 2."

Section 6. That in addition to the general and special powers provided to the District under Chapter 190, Florida Statutes, the District shall have the special power to plan, establish, acquire, maintain additional systems and facilities for:

- (a) Parks and facilities for indoor and outdoor recreation, m cultural and educational uses;
- (b) Control and elimination of mosquitoes and other arthropods of public health importance;
- (c) To build and turn over to the Board of County Commissioners of Sumter county, Florida, a public services building as required by the Development Order entered in connection with the establishment of the Orange Blossom Gardens Development of Regional Impact West and the Tri County Villages Development of Regional Impact;
  - (d) Water mains and plugs for fire prevention and control;
- (e) Fire truck and other vehicles and equipment, including the right to transfer any of the same to the appropriate agency which provides fire service within the District. Power to operate the fire fighting equipment is specifically withheld.
  - (f) Security as set forth in Fla. Stat. Sec. 190.012 (1)(d).

Section 7. That all ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed to the extent of such conflict.

Section 8. That if any section, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this ordinance.

Section 9. That this ordinance shall become effective in accordance with law.
