ORDINANCE NO. 02018-20

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF WILDWOOD, FLORIDA, AMENDING THE TITLE OF ORDINANCE O2018-18 TO CORRECT A SCRIVENER'S ERROR; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission of The City Of Wildwood (the "City") adopted Ordinance Number O2012-20 on June 25, 2012 establishing The Brownwood Community Development District (the "District"); and

WHEREAS, the City Commission of The City Of Wildwood adopted Ordinance Number O2013-28 on July 8,2013 to reflect a new legal description and amended boundary of the District; and

WHEREAS, the District has approved a petition to the City requesting that the legal description included in Exhibit "A" to Ordinance O2012-20 and O2013-28 be amended to reflect a net increase in the size of the District of 41.4 acres, more or less; and

WHEREAS, the District has filed a "Petition to Amend the Boundaries of the Brownwood Community Development District" (the "Petition"), pursuant to and in compliance with Section 190.046, Florida Statutes; and

WHEREAS, in the Petition, the District requests that the City pass an ordinance amending Ordinance O2012-20 and O2013-28, to reflect the new legal description and amended boundary of the District; and

WHEREAS, on or about March 26, 2018, the City Commission of the City of Wildwood adopted Ordinance Number O2018-18, amending Ordinance Numbers O2012-20 and O2013-28; and

WHEREAS, the City recognized a scrivener's error in the title of Ordinance O2018-18; and

WHEREAS, the City wishes to correct said scrivener's error in the title of Ordinance O2018-18 with the adoption of this Ordinance; and

WHEREAS, it is the intent of this Ordinance to amend the title of Ordinance O2018-18 to correct the scrivener's error;

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Wildwood, Florida that Ordinance Number O2018-18 is hereby amended as follows:

SECTION 3: Effective Date. This Ordinance shall be retroactively effective upon the date of adoption of the original Ordinance O2018-18 by the City Commission of the City of Wildwood.
