ORDINANCE NO. 04 - 23

AN ORDIANANCE OF THE BOARD OF COUNTY COMMISSIONERS OF SUMTER COUNTY, FLORIDA, AMENDING ORDINANCE NO. 02-5 AS AMENDED BY ORDINANCES 02-24 AND 2003-15 TO FURTHER AMEND THE BOUNDARY OF THE VILLAGE COMMUNITY DEVELOPMENT DISTRICT NO. 5 PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners established the Village Community Development District No. 5 by Sumter County Ordinance 02-5 adopted on March 19, 2002, and

WHEREAS, the boundaries of the Village Community Development District No. 5 were subsequently amended by Sumter County Ordinance 02-24 adopted on October 8, 2002 and 2003-15 on August 19, 2003, and

WHEREAS, in the process of going forward with development activities it has come to the attention of the developer that additional changes are necessary in the boundary to delete approximately 1.5 acres,

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Sumter County, Florida, as follows:

- Section 1. Section 3 of Sumter County Ordinance 02-5 is hereby amended soft that the external boundary of the District shall be as per Exhibit A attached hereto.
- Section 2. That all ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed to the extent of such conflict.
- Section 3. That if any section, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this ordinance.

Section 4. That this ordinance shall become effective in accordance with law. PASSED this 28 day of ______, 2004.
