AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF SUMTER COUNTY, FLORIDA, AMENDING ORDINANCE 98-10 BY AMENDING THE SECTION 6, OF SAID ORDINANCE TO CORRECT TYPOGRAPHICAL ERRORS AND STATUTORY REFERENCES, PROVIDING FOR REPEAL OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners established the Village Community Development District No. 3 by Sumter County Ordinance 98-10 adopted on May 12, 1998, and

WHEREAS, Section 6 of the ordinance granted certain additional powers pursuant to Fla. Stat. Sec. 190.012 (2), but the ordinance did not precisely tract the language of that statute and it contained typographical errors, and

WHEREAS, the language in said ordinance did in fact grant to the District the additional powers contained therein, but the Board would prefer that the ordinance tract verbatim the language of the statute,

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Sumter County, Florida, as follows:

Section 1. Section 6 of Sumter County Ordinance 98-10 is hereby amended to read as follows:

Section 6. That in addition to the general and special powers provided to the District under Chapter 190, Florida Statutes, the District shall have the special power to plan, establish, acquire, construct or reconstruct, enlarge or extend, equip, operate, and maintain additional systems and facilities for:

- (a) Parks and facilities for indoor and outdoor recreational, cultural, and educational uses.
- (b) Fire prevention and control, including fire stations, water mains and plugs, fire trucks, and other vehicles and equipment.
- (c) Security services as provided in Fla. Stat. Sec. 190.012 (2) (d).
- (d) Control and elimination of mosquitoes and other arthropods of public health importance.

Section 2. That all ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed to the extent of such conflict.

Section 3. That if any section, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this ordinance.

Section 4. That this ordinance shall become effective in Section 4. Th accordance with law.

Vice Chairman Dick Belles called the meeting to order, followed by the Pledge of Allegiance. John Sullivan and Tillman Dean were absent. Dick Belles, Gale Lazenby and Charlie Cook were present, constituting a quorum.

Also present were staff members, Pete Wahl, Monica Andersen and Jimmy Crawford.

Glenbrook resident Lou Conrad congratulated the Board regarding the paving work done on Buena Vista and the light on Buena Vista.

Minutes for the November meeting were approved with modifications.

Monica Andersen reported the budget balance is \$228,324 unaudited. A proposal to remove the walking path in the Savannah tunnel, under Buena Vista, for \$16,478 was submitted by Bill Gregory was accepted. Other contractors rejected the job and did not bid.

Curbing at the west end of the tunnel at Hawkes Bay was put on hold at this time.

The bushes that were obstructing the view on the golf cart path on the Sumter-Marion line on Buena Vista were cut back or removed.

Pete Wahl reported the traffic light on Southern Trace and Buena Vista Blvd will be operational on December 15, 2005.

Monica Andersen reported she received a letter from Tony Battaglia regarding LSV carts using the golf cart path. A meeting with all districts will be planned. Gale Lazenby will represent District 3. Mr. Battaglia was involved in an accident with his golf cart and Gem cart.

Charlie Cook asked who was responsible for trees that obscure the street signs on Oak Forest Drive. Pete Wahl his staff will notify Sumter County Public Works.

Gale Lazenby asked the staff to send a thank you letter to Mike Francis and Dick Hoffman for getting the traffic light and paving done on Buena Vista Blvd.

Pete Wahl requested the supervisors and residents attend the County Board of Supervisors meeting when they meet at Laurel Manor.
