ORDINANCE NO. 02020-50

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF WILDWOOD, FLORIDA, AMENDING THE BOUNDARIES OF THE **VILLAGES** COMMUNITY DEVELOPMENT DISTRICT NO. 13 PURSUANT TO FLORIDA STATUTE 190.046: RATIFYING CONSENTING TO THE POWERS AUTHORIZED IN SECTION 190.012(1) AND 190.012(2) **FLORIDA PROVIDING** STATUTES: FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission of the City of Wildwood, Florida Board established the Village Community Development District No. 13 ("District") by Ordinance O 2018-26 and amended the District by Ordinance O 2019-44; and

WHEREAS, the District has approved a Petition to the City of Wildwood requesting that the legal description included in Exhibit "A" to Ordinance O 2018-26 as modified by Ordinance 02019-44 be amended to reflect a net decrease in the size of the District by 48.2 acres, such that the resulting District will total 2,241.8 acres, more or less; and

WHEREAS, in the Petition, the District requests that the City pass an ordinance amending Ordinance O2018-26 and Ordinance O2019-44, to reflect the new legal description and amended boundary of the District, and;

NOW THEREFORE, BE IT ORDAINED by the City Commission of the City of Wildwood, Florida, as follows:

Section 1. Petition. The "Petition to Amend the Boundaries of Village Community Development District No. 13 pursuant to Florida Statutes 190.046" as submitted to the City of Wildwood Commissioners, is hereby GRANTED.

Section 2. Modification of Map and Legal Description. Ordinance O2018-26 and Ordinance O2019-44 are hereby amended so that the external boundary of the District shall be as per Exhibit "A" attached hereto.

Section 3. Ratification and Consent. The City Commission of the City of Wildwood, Florida, ratifies and consents to the special powers authorized in Section 190.012(1) and 190.012(2) Florida Statutes as requested by the petitioner.

Section 4. Conflict. All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed to the extent of such conflict.

Section 5. Severability. If any section, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this ordinance.


