HOLIDAY SANITATION THANKSGIVING



Village Community Development Districts 1-11

If you live in Village Community Development Districts 1-11 in the Sumter County, Marion County or Fruitland Park portions of The Villages, there will be no sanitation collection on Thursday, November 28, 2024. Collection will be on Saturday, November 30, 2024.

Village Community Development District No. 12 and the Villages of DeLuna and Hammock at Fenney

If you live in Village Community Development District 12 or the Village of DeLuna and Hammock at Fenney there will be no sanitation schedule change due to the holiday.

Village Community Development District 13 (excluding Villages of DeLuna and Hammock at Fenney) and District 14

If you live in Village Community District 13 (excluding Village of DeLuna and Hammock at Fenney) and District 14, there will be no sanitation collection on Thursday, November 28, 2024. Next collection will be on Saturday, November 30, 2024.

If you live in the **Lake County portion of The Villages** (not including VCDD No. 11 or 14), Thursday collection will be moved to Friday, November 29, 2024 and Friday collection will be moved to Saturday, November 30, 2024.

If you live in the **Town of Lady Lake portion** of The Villages, there will be no sanitation collection on Thursday, November 28, 2024. Next collection will be on Monday, December 2, 2024.

POST-HURRICANE DEBRIS HAUL SCHEDULE

Following Hurricane Milton, the Village Community Development Districts engaged our debris hauling contractor, Ceres, to handle storm debris collection throughout The Villages. As local government entities, each District qualifies for Federal Emergency Management Agency (FEMA) reimbursement for these cleanup efforts. Debris removal must be accurately coordinated, tracked, and separated (by District) for FEMA reimbursement purposes; so, this is a carefully planned, monitored, and executed operation. Debris collection began October 20, 2024, and crews are working daily from sunrise until approximately sundown. To date, over 8,340 cubic yards of debris has been collected in The Villages.

Given our community's extensive size of over 90+ square miles, please be patient as the debris is collected. We are now beginning collection in residential areas and will continue to provide updates on when you can anticipate collection in your district.

Debris collection has been completed along the following roadways:

Morse Blvd, El Camino Real, Buena Vista Blvd (north of District 9), Fenney Way, Canal St, Hillsborough Trail, Meggison Road, Odell Circle, Pinellas, Bonita Blvd, Stillwater Trail, Rainey Trail, Avenida Central, Warm Springs, Rio Grande, Marsh Bend Trail, Moyer Loop, St. Charles Place, Recreation Centers, Fire Stations

Debris collection has been completed in the following residential areas: Districts 2 and 4

Work is currently underway in the following residential areas: District 1, District 3, and District 6 and Lady Lake / Lake County portion of The Villages

Important Guidelines for Residents:

To ensure efficient collection and maintain community safety, please -

- Place all storm debris in the right of way of your residential property **IN THE GRASS**;
- Do not place debris in roadways, cul-de-sacs, or on driveways; and
- Keep debris clear of storm drain inlets and electrical boxes, and please do not use plastic bags for any storm debris.

As a reminder, storm debris eligible for special pickup includes items directly damaged or displaced by the hurricane, such as fallen tree branches, uprooted shrubs, broken fences, and roofing materials torn off by high winds. In contrast, regular yard maintenance waste, which is not eligible for this special collection, includes routine grass clippings, pruned branches from regular trimming, seasonal leaf fall, and hedge trimmings from normal landscaping activities.
