VCDD as a Community

The Villages population is larger than 96% of the municipalities in the State of Florida. (14th largest of 411)

• The Villages population is larger than 33 of the 67 counties in the state of Florida.

What Is an Independent Special District?

- » It is created by the State Legislature with Local Government Approval for a:
- Specific purpose and a specific area.
- The Special District derives its authority from provisions in Florida State Statutes.
- However, the funding and purview of each one is set by the Legislature.

EXAMPLES OF INDEPENDENT SPECIAL DISTRICTS INCLUDE:

- Community Development Districts (Florida State Statute 190)
- Water Management Districts
- Inland Navigation
- Fire Service

What Is a Dependent Special District?

- » It is created by the city and/or county it resides within:
- The Special Districts are created pursuant to provisions in Florida State Statutes. However, Districts derive their authority from the government that created them.

EXAMPLES OF DEPENDENT SPECIAL DISTRICTS INCLUDE:

- · Downtown improvement authorities
- · Community redevelopment authorities
- · Special taxing districts
- In The Villages, the North Sumter County Utility Dependent District, Wildwood Utility Dependent District, and Villages Public Safety Department Dependent District. (Florida State Statute 189)

The History of Chapter 190

- In 1822, before Florida became a state, there was a Special District under the territorial governing mechanism for roads and highway "The Road, Highway and Ferry Act".
- In 1845 a Drainage District was created to simply drain a swamp.
 - » Five commissioners were empowered to drain the "Alachua Savannah". To finance the project, the first special assessments were made on landowners based on the number of acres owned and the benefit derived.
- In 1913 the State passed the first general drainage law, the "General Drainage law of 1913" which evolved into the current Chapter 298.
- Developers and attorneys (who were very creative) took the old Chapter 298 (which provided for only draining properties) to the legislature with the property they owned and asked the legislature for additional powers such as roads, bridges, water, sewer and sometimes parks and recreation.
- As a result of using Chapter 298, there was no uniform or consistent application of special district powers – each District was different and operated under whatever authority was granted at the time of the request.
- During 1973 to 1974, Governor Ruben Askew became concerned about "districts" and developments being "custom made" with no accountability, no standards and no uniformity.
- So, in 1975, the State enacted the New Communities Act to help the development process. However, although it provided a more uniform method of development, it was very difficult to use and was not creating the economic development first envisioned when it was created. As a result, development laws and rules began to be overhauled.
- In 1980, the Legislature, along with interested parties and the State Community Affairs Committee, asked the question: Are Special Districts in the State's interest?
 - » Their answer was YES.
- As a result, the legislature adopted Chapters 189 and Chapter 190 – Chapter 190 is the legislative authority for the Community Development Districts, which are independent units of special purpose government.

Chapter 190 Legislative Intent

The need to encourage new, large-scale communities that included long range planning, management, financing and a perpetual entity to operate and maintain community infrastructure.

To allow large landowners the mechanism to invest the time and financial resources to undertake a large-scale new community, the legislature created a public private partnership.

Why We and the State of Florida Have Special Districts

- Creates a governing board of elected members to focus on the specific community needs and issues the special district is addressing. And establishes a council-manager form of government to provide efficient management of the District.
- Districts allow municipalities and counties to focus on general government issues. The Districts do not duplicate services offered by the cities and counties.
- Generates money to pay for projected growth without putting an excessive burden on other taxpayers and governments, since only those who benefit from the special district's services are required to pay.
- Ensures accountability of public resources, since special districts, cities and counties are held to high standards (e.g., Ethics, Sunshine Law, Public Records Law, Financial Reporting, Financial Disclosure Laws.)
- Protects property values by assuring property owners that their roads, water and sewer lines, and other essential facilities and services will continue to be maintained.
- Saves money for affected citizens by selling tax-exempt bonds, purchasing essential goods and services tax-free, and participating in state programs and initiatives.
- Maintains the financial integrity of the special district by limiting its liability to civil lawsuits and providing state and federal assistance in the event of a financial emergency.

What Next?

Developer petitions the State and Local Government to establish Chapter 190 District

Local Government reviews and, if approved, State then reviews and, if approved, establishes Community Development District

Landowners elect Board Members (Board members begin to transition to qualified elected positions when the District is both 6 years old and has a minimum of 250 qualified electors residing in the District)

> Developer enters into Interim Funding Agreement with District

Developer begins construction of infrastructure as required by local government

District issues bonds based on Engineer's Report of estimated cost of infrastructure construction

Developer is reimbursed for construction costs up to estimated cost (bond amount) - any additional costs are the Developer's responsibility

District Bonds are paid off through assessments on individual properties. Either paid in full or are billed on Annual Tax Bill

Other than road infrastructure annual maintenance assessments on tax bill pay for the upkeep and operation of the District's infrastructure built with the bond proceeds of the District

- Newly established Community Development Districts are restricted in size to no greater than 2500 acres.
- Existing CDDs (also commonly called Residential Districts) can amend their boundaries no greater than 50% of the cumulative net total of the land in the initial district, and no greater than 1,000 acres on a cumulative net basis.

The elected Board of Supervisors within each District levies Assessments (taxes) on property owners within that district to operate, maintain and manage infrastructure owned by that District.

Project Wide Fund

South of CR466 has a unique mechanism to manage the maintenance assessments needed for "common" areas. Infrastructure such as landscape along major roadways, storm water facilities, tunnels, multi-modal paths, etc. are paid for through a Project Wide Fund (PWF). The PWF receives its revenue from Districts 5-13, Sumter Landing and Brownwood Community Development Districts based on assessable acreage and the funds are used to maintain the common areas.

Project Wide Advisory Committee

The Project Wide Advisory Committee (PWAC) was established by Resolution 13-05 of the Sumter Landing Community Development District (SLCDD) and is comprised of a Board Supervisor from Village Community Development Districts 5-13. The resolution provides the PWAC will:

- Provide input, explore issues and provide advice and recommendations to the SLCDD on issues related to the maintenance of Project Wide Improvements.
- Review and recommend the annual budget to the SLCDD, review budget to actual statements
- Review and recommend contract renewals and bid/proposal awards to the Board related to the Project Wide Improvements.
- Explore significant and important issues pertaining to the Project Wide Improvements as they arise and provide advice and recommendations to the SLCDD.

Eastport Maintenance Advisory Committee

DISTRICTS 14-15 & EASTPORT COMMUNITY DEVELOPMENT DISTRICT

The Eastport Maintenance Advisory Committee (EMAC) was established by Resolution 2023-09 and is comprised of a Board Supervisor from Village Community Development Districts 14-16 & Eastport Community Development District. The resolution provides the EMAC will:

- Provide input, explore issues and provide advice and recommendations to the Eastport Community Development District on issues related to the maintenance of Project Wide Improvements.
- Review and recommend the annual budget to the Eastport Community Development District, review budget to actual statements.
- Review and recommend contract renewals and bid/proposal awards to the Board related to the Project Wide Improvements.
- Explore significant and important issues pertaining to the Project Wide Improvements as they arise and provide advice and recommendations to the Eastport Community Development District.

VCDD Management Services

The VCCDD provides the management services and general government services for all other Districts within The Villages and the North Sumter County Utility Dependent District (NSCUDD) and the Wildwood Utility Dependent District (WUDD) as well as Villages Public Safety Department Dependent District (VPSDDD). The use of the VCCDD as a "management" company provides the rest of the Districts a benefit from economy of scale. The type of services cost allocated to the other Districts, include personnel, buildings and overhead (electric/ phones/landscaping, operating supplies, and equipment).





Amenity Fees

- Resident purchases home.
- Resident signs Contract to pay amenity fees in exchange for services.
- When offered, Amenity fee contractual agreements were sold to VCCD and SLCDD who provides amenities in accordance with the contract (fee for services).
- Payment of the Amenity Fee is required through the Contract you signed when you bought your home. The contract requires you to adhere to the Declaration of Restrictions (Restrictions) for your unit/lot.
- Amenity Fee is paid for in exchange for Amenity Services- it is a FEE FOR SERVICES.
- Depending on your Restrictions, your Amenity Fee increases every year or every three years.
- Depending on your Restrictions, your Amenity Fee increase is based on either the date you signed your contract or the original land sale date.
- The Amenity Fee increase is based on the CPI and CANNOT be increased or decreased greater than that amount each year (or every three years depending on your Restrictions).

The current prevailing rate for all new homebuyers (and resales post 1/1/25) is \$199.00/month.

Project Wide Advisory Committee

ESTABLISHED 2017

Resolution 17-11 was adopted by the SLCDD on May 18, 2017 to expand the duties and responsibilities of the Project Wide Advisory Committee (PWAC) to provide input, explore issues and provide recommendations on issues related to SLCDD owned Amenity facilities.

- Discretion over all Non-Bond Recreation Amenity Division Funds.
- · Rate setting of Amenity Facility user fees.
- Policy control over operations of Amenity Facilities and Services.
- Prohibited from establishing disparate services north and south of CR466.
- Restricted from involvement in Public Safety, Management fees/services.

Governed by Board of Supervisors

- Supervisors are State of Florida elected officials and are subject to state laws that all elected officials must adhere to such as ethics, financial disclosure, public records, etc.
- Meet during regular monthly meetings and hold workshops as necessary to discuss budgets and policies as they relate to their individual District responsibilities.
- Meetings are advertised and agendas are included on the DistrictGov.org website one week prior to the meeting.
- Summary minutes are prepared for the Board and committee approval.
- Set policies, adopt budgets, approve contracts, address resident issues/concerns.
- Supervisors may choose to be paid \$200 a meeting up to a maximum of \$4800 per year.

Getting Involved

- After the 6th year or 10th year, once the District reaches 250 or 500 qualified electors, respectively the transition will begin and two of the three seats become qualified.
- Each District is governed by a Board which is either elected by a Landowner or Qualified (Registered Voter) Election.
- Voting in a Landowner Election Not required to be a registered voter within the State of Florida, but must be a landowner to vote. A Landowner Election is separate from the general election. A Landowner Election allows one vote per acre or part (parcel) thereof.
- Voting in a Qualified Election Required to be a registered voter in the State of Florida. If there is a contested race for a Seat on the Board of Supervisors, the election will be included on the General Election ballot. All registered voters are entitled to one vote.

Sunshine Law

Sunshine Law applies to any gathering or communication between two or more Board members of the same Board to discuss any matter which foreseeably could come before the Board.

Requirements:

- · All Board meetings must be open to the public
- Reasonable notice of meetings must be given
- · Minutes of the meeting must be taken
 - » Board Members can be friends and are able to have lunch, golf and attend social gatherings together just as long as they do not discuss any Board business.

The Florida Supreme Court has determined that public records are all materials made or received by a Board in connection with official business. As soon as a document is received by the District it becomes a public record. The District Clerk serves as the VCDD's Boards' Custodian for public records. Any individual can make a public records request and State Law requires the custodian honor the request. Requests can be made in person, telephone or via e-mail.

State Law provides the District the authority to charge \$.15 per single-sided copy; however, if the nature of the request is extensive, the District may charge a reasonable service charge.





VPSD SERVICE AREAS

Established in 1999, the VPSD has provided fire protection and emergency medical services to the areas of The Villages since October 1, 1999. Initially the Department was comprised of one station (Station 41- Lake Sumter Landing), one Fire Chief, and 12 firefighter/paramedics.

VPSD responded to 1,040 calls for service during the first year of operations, and the response area covered approximately 3 square miles.

As of 2025, VPSD is comprised of over 180 Firefighters/Paramedics/EMTs, 9 Battalion Chiefs, and 28 Administrative Personnel. Additionally, VPSD has a Heavy Technical Rescue Team, recognized by the State of Florida, which is a team of firefighter/EMTs and firefighter/ paramedics specializing in various rescue techniques. VPSD deploys resources out of 9 Fire Stations strategically located throughout The Villages, covering an expansive response area over 90 square miles, and protecting a population of over 153,000.

TECHNICAL RESCUE TEAM

The Villages Public Safety Department's Technical Rescue Team (FL-TRT-424) is a Type I (heavy) technical rescue team, recognized by the State of Florida. Team members are firefighter/ EMTs and firefighter/paramedics specializing



in High Angle Rope Rescue, Vehicle Machinery Rescue, Confined Space Rescue, Trench Collapse Rescue, and Structural Collapse Rescue. Some members are also certified in Large Animal Rescue and Swift Water Rescue. VPSD's Technical Rescue Team is a local, regional, and state asset.

INSURANCE SERVICES OFFICE (ISO) RATING

The Villages Public Safety Department (VPSD) earned the second highest rating available from the Insurance Services Office (ISO) this year.

VPSD received a Class 2/2Y rating, which indicates superior fire protection based on the comprehensive evaluation of the department's apparatus, equipment, station locations, and water supply.



ISO ratings have a significant role in the underwriting process of insurance companies, as the rating information is utilized by most insurance companies to determine insurance policy and coverage information, including policy premiums, for personal or commercial property insurance. These ratings occur once every 5 years.




PARADISE RECREATION

STORM WATER PIPES

District Property Management maintains stormwater pipes on District property outside the road right-of-ways.

The District adheres to the guidelines set forth by the National Pollutant Discharge Elimination System (NPDES) Compliance Permit. This program is administered by the State of Florida through the Department of Environmental Protection and is required by the Federal Clean Water Act.

The District adopted policies that prohibit the illicit discharge of pollutants into our storm drain system and drainage basins. Some examples of these pollutants include oil, automotive fluids, paints, stains, pesticides, discarded or abandoned objects, and other liquid and solid wastes.

Preserves & Wetlands Management

The District currently owns and manages 2,800+ acres of wetlands and 600+ acres of preserves.

- » Why wetlands are important to The Villages:
- Benefits storm water management by collecting and storing runoff
- Provides flood protection and water retention for residential and urban areas
- Filters and removes pollutants such as nitrogen and phosphorus
- Provides food, water, and shelter for wildlife (some of which are protected)
- Provides habitats for flora and fauna, which are among the most productive ecosystems in the world, comparable to rainforests and coral reefs

Improvements and associated maintenance are included in the permit conditions and maintained in accordance with those requirements.

The District does not maintain these areas for private property views, as these areas are designated as wetland preservation areas. These areas are strictly protected and are not authorized for any development or change.

Unauthorized trimming, cutting and/or removal of trees or vegetation is illegal and may result in criminal actions or fines.



All waste is collected throughout the Villages is transported to Reworld Themomechanical Treatment Facility (RTTF). This collection is part of a "Waste-to-energy" program that diverts waste from landfills to generate energy from the combustion of municipal solid waste. At the time of purchase, there were 39,700 residential and 200 commercial accounts. Today, Sumter Sanitation services approximately 53,670 residential and 304 commercial accounts in Districts 1-11 and commercial properties north of 44 in Marion County, Sumter County, and the Fruitland Park areas of The Villages. NSCUDD partners with Jacobs and Reworld for the collection and disposal of solid waste.

SOLID WASTE DISPOSAL

Sumter Sanitation utilizes a "Waste-to-Energy" program that diverts waste from landfills to generate energy from the combustion of municipal solid waste. Waste-to-Energy facilities convert waste to power steam turbines which generate electricity for homes and businesses, reducing greenhouse gases and landfill waste. The resulting ash is processed to recover metal for recycling while all gases are collected, filtered and cleaned to minimize environmental impact.




