If you live in Village Community Development Districts 1-11 in the Sumter County, Marion County or Fruitland Park portions of The Villages, there will be no changes to the sanitation collection schedule on Monday, May 26, 2025.

Village Community Development Districts 12-15

If you live in Village Community Development District 12-15 of the Villages, there will be no changes to the sanitation collection schedule on Monday May 26, 2025.

If you live in the **Lake County portion of the Villages** (not including VCDD No. 11 or 14), Monday collection will occur on Tuesday. All collection days for the week will be moved to the next day.

If you live in the **Town of Lady Lake portion** of The Villages, Monday services will be performed on Thursday, May 29, 2025.

If you live in the **Middleton Community Development District**, there will be no changes to the sanitation collection schedule.

Water Service Line Replacement Program

In our continued commitment to improve the quality of life and maintain the utility infrastructure within The Villages, The Village Center Community Development District has initiated a Water Service Line Replacement Program in the Villages Center Service Area (VCSA).

The potable water system in VCSA is aging and the purpose of the project is to replace service lines, significantly reducing the future potential for leaks. Water service lines bringing water from the water main to household water meters will be replaced as part of this project. During construction, water outages may occur at different times, depending on which area workers are concentrating on. No residents will be without water service during overnight hours. This upgrade to the water system will enhance reliability and service.

Beginning May 27th, 2025, District Contractor, RCM Utilities, LLC., will begin replacing the water service connections in Villa de la Mesa in District 1 of The Villages, along Dominguez Dr., Delgado Ave., and Ramirez Ave. The project is expected to take 8 weeks.

During construction, homeowner's water service will be off for no more than eight hours. Homeowners will be given 24-hour notice of when their service will be impacted by way of a door hanger placed on their door. If required, boil water notices will be sent to residents which will be in effect for a 2-day testing period. The safety of our residents and construction personnel is of utmost importance. We ask that everyone abide by all barricades and warning signs to avoid the active construction areas for anything other than access to your property.

These pools are intended for refreshing socialization and not for organized or scheduled activities. Noodles, unbreakable masks and goggles are the only items allowed in the pool. Regularly scheduled water exercise groups are encouraged to use the Sports Pools for this purpose.

For All Residents & Guests (Regardless of Age)*

Noodles, unbreakable masks, goggles, and small buckets are the only items allowed in these pools.

*Guests under 19 years of age must be accompanied by a Villages resident or a guest 19 years of age or older with a valid guest ID and photo ID.

Guest ID Cards

Guests of Villages' residents whose home address is outside Lake, Sumter, and Marion Counties are eligible to use selected Villages' resident amenity-supported recreational facilities.

An original Villages Guest ID Card is required for all guests one (1) year of age and older. Guest ID Card Services are available 7 days a week:

Monday – Friday 8:30am – 5pm: District Customer Service and all At You Service Centers (Paradise, Savannah, Mulberry Grove, Laurel Manor, Lake Miona, Colony Cottage, SeaBreeze, Eisenhower, Rohan, Fenney, Everglades and Ezell); Saturday and Sunday 8:30 am – 12 pm: Lake Miona, Eisenhower, Rohan and Everglades At You Service Centers Only.

SOLID WASTE BULK PICK-UP

Residents of Districts 1- 11

The following items can be placed in your regular household waste pick-up:

- Lamps
- Plastic Chairs
- Ceiling fans (blades must be removed)
- Brooms
- Pallets
- Carpeting and/or padding (No larger than 4' x 4' & less than 40 lbs.)

A Bulk Item Pick-Up will need to be scheduled for larger items such as:

- Microwaves and small kitchen appliances
- Office chairs/desk chairs/kitchen chairs
- 2-burner grills
- Flat-screen TVs
- Ironing boards
- Electronics (computers, stereo equipment, monitors etc.)
- Furniture (oversized chairs, mattresses, box springs, etc.)
- Appliances (washer, dryer, dishwasher, refrigerator)
- Lawn Mowers
- Exercise Equipment
- Remodeling debris generated by the homeowner ONLY (sinks, toilets, carpeting, lumber etc.)

***All Contractors are required to remove all debris from their jobs. This includes lawn maintenance, tree trimmers, builders, carpet installers, roofers, etc.**
