COMMUNITY DEVELOPMENT DISTRICT UPDATE

The Southwest Florida Water Management District (SWFWMD) has placed a Phase 1 Water Shortage Order for areas within The Villages. This shortage order began on December 1, 2025, and is scheduled to run through July 1, 2026, and applies to counties and cities in our vicinity as well.

While this order does not make changes to existing two day per week irrigation, it does prohibit “wasteful and unnecessary” use, such as allowing water to flow from an unattended hose.

Christmas Day

Village Community Development Districts 1-11

If you live in Village Community Development Districts 1-11 in the Sumter County, Marion County or Fruitland Park portions of The Villages, Thursday collection will occur on Saturday, December 27, 2025. Friday collection will have normal services.

Village Community Development District No. 12 and the Villages of DeLuna and Hammock at Fenney, Thursday collection will occur on Saturday, December 27, 2025. Friday collection will have normal services.

Village Community Development District 13, (excluding Villages of DeLuna and Hammock at Fenney) and District 14 Thursday collection will occur on Saturday, December 27, 2025. Friday collection will have normal services

If you live in the **Lake County portion of The Villages** (not including VCDD No. 11 or 14), Thursday collection will occur on Friday. All remaining collection days for the week will be moved to the next day.

If you live in the **Town of Lady Lake portion of The Villages**, Thursday services will be performed on Friday, December 26, 2025.

Village Community Development District 15 (excluding Villages of Oak Hollow and Well Point) the Thursday pick up will be rescheduled to Saturday, December 27, 2025.

SANITATION COLLECTION

- All household solid waste and yard waste are picked up twice a week - between 6 am - 5 pm.
- All household waste should be placed in sealed tall kitchen trash bags, or 20–30-gallon trash bags. Any color is acceptable except for red, which is used for medical waste.
- All materials can be placed in the same bag, no need to sort.
- The trash bags should be left at the end of your driveway. NO garbage cans are allowed, or they will be disposed of along with the household waste.
- Each bag should weigh no more than 40 pounds.
- Bags must be placed for collection before 6 AM on collection day, or the night before, no earlier than 5 PM.
- Wrap broken glass or sharp objects in newspaper and place them where they are unable to cause an injury.
- Tree limbs and branches should be bundled and tied, and may not exceed 5" in diameter, 5' in length, or exceed 40 pounds.



The use of any application of this service is for limited WiFi capability, and to assist our residents within the lobby areas, with limited service in the recreation centers.


